Background



General observations

The indications of the products or services that appear in the titles of the classes constitute general indications relative to the sectors to which these products or services belong in principle. That is why it is important to consult the alphabetical list to ensure the exact classification of each specific product or service.

Products

If a product can not be classified using the list of classes, the explanatory notes or the alphabetical list, the following observations indicate the criteria that should be applied:

- a) A finished product is classified, in principle, according to its function or its destination. If the function or destination of a finished product is not mentioned in any title of the classes, this product is classified by analogy with other similar finished products that appear in the alphabetical list. If none exist, other criteria are applied such as the matter of which it is made or its mode of operation;
- b) A finished product with multiple uses (such as a radio-alarm combination) can be classified into all the classes that correspond to each of its functions or its destinations. If these functions or destinations are not mentioned in any class title, the other criteria mentioned in section a) apply.;
- c) Raw materials, raw or semi-processed, are classified, in principle, taking into account the subject matter of which they are constituted;

Products

- d) The products destined to be part of another product are not, in principle, classified in the same class as the latter; they are only available in cases where products of this kind can not normally have other applications. In all other cases, the criterion established in section a) applies;
- e) If a product, finished or not, that must be classified according to the subject matter of which it is constituted, is in fact constituted by different subjects, the classification is made, in principle, according to the predominant material;
- f) The kits adapted to the products they will contain are classified, in principle, in the same class as the latter.

Services

If a service can not be classified using the list of classes, the explanatory notes or the alphabetical list, the following observations indicate the criteria that should be applied:

a) Services are classified, in principle, according to the branches of activities defined by the titles of the classes of services and their explanatory notes or, if not, by analogy with other similar services that appear in the alphabetical list;

Services

- b) All rental services are classified, in principle, in the same classes in which the services that are provided with the help of the rented objects are classified (for example, telephone rental, which belongs to class 38). Leasing services are similar to rental services and therefore should be classified in the same way. However, leasing with a purchase option (leasing) is classified in class 36, since it is a financial service.
- c) The advisory services, information or consultation are classified, in principle, in the same class as the services on which the advice, information or consultation is concerned. For example, consultations on transport (cl 39), queries on the management of commercial businesses (cl 35), consultations on financial matters (cl 36), consultations on beauty care (cl 44). The electronic communication of this advice, information or consultation (by telephone, via computer) has no effect on the classification of the service.

d) In principle, the services provided under the franchises are classified in the same class as the specific services offered by the franchisor (for example, business advice related to franchises (cl. 35), financial services related to franchises). (cl 36) and legal services related to franchises (cl 45).

CLASS 1 Chemical products for industry, science and photography, as well as for agriculture, horticulture and forestry; unprocessed artificial resins, raw plastics; fertilizers for the soil; extinguishing compositions; preparations for tempering and welding metals; chemical products for preserving food; tanning materials; adhesives (glues) for industry.

This class includes in particular:

- compost and organic fertilizers;
- preservation salt other than for preserving food;
- certain additives intended for the food industry (see the alphabetical list of products).

This class does not understand in particular:

- natural crude resins (Cl 2);
- chemical products for medical sciences (cl.5);
- fungicides, herbicides and products to eliminate harmful animals (cl.5);
- adhesives (glues) of stationery or for domestic use (Cl 16);
- salt to preserve food (cl 30);
- the mulch (humus cover) (cl 31).

CLASS 2 Paints, varnishes, lacquers; products against rust and deterioration of wood; dyeing materials; mordants; natural crude resins; metals in foil and powder for painting, decoration, printing and artistic works.

This class includes in particular:

- paints, varnishes and lacquers for industry, crafts and art;
- dyes for clothing;
- colorants for food and drinks.

This class does not understand in particular:

- the crude artificial resins (Cl 1);
- the dyes for washing and whitening clothes (Cl 3);
- the cosmetic dyes (Cl 3);
- the paint boxes (school equipment) (cl 16);
- paints and insulating varnishes (cl 17)

CLASS 3 Bleaching preparations and other substances for washing clothes; preparations for cleaning, polishing, degreasing and scraping; soaps; perfumery products, essential oils, cosmetics, hair lotions; dentifrices.

This class includes in particular:

- deodorants for people or animals (perfumery products);
- the products to perfume the environment;
- personal care products that are toilet products.

This class does not understand in particular:

- chemical products for cleaning chimneys (Cl.1);
- degreasing products for manufacturing processes (Cl.1);
- deodorizers that are not for people or animals (cl 5);
- Sharpening stones or sharpening wheels (hand tools) (Cl.8).

CLASS 5 Pharmaceutical products, preparations for medical and veterinary use; hygienic and sanitary products for medical use; food and dietetic substances for medical or veterinary use, baby food; food supplements for people or animals; plasters, material for dressings; material for dental fillings and imprints; disinfectants; products to eliminate harmful animals; fungicides, herbicides.

This class includes in particular:

- personal hygiene products other than toiletries;
- diapers for babies and incontinent;
- deodorizers that are not for people or animals;
- food supplements intended to complete a normal diet or to benefit health;
- substitutes for meals, food and dietetic beverages for medical or veterinary use;
- cigarettes without tobacco for medical use.

This class does not include in particular:

- personal hygiene products that are a toilet (Cl 3);
- deodorants for people or animals (perfumery products) (Cl 3);
- orthopedic bandages (cl 10);
- substitutes for meals, foods and diet drinks that are not for medical or veterinary use (cl.

This class includes in particular:

- motor parts (of all kinds);
- electric cleaning machines and appliances.

This class does not include in particular:

- certain machines and special machine tools (consult the alphabetical list of products);
- manually operated hand tools and instruments (Cl.8);
- engines for land vehicles (cl 12).

This class includes in particular:

- knives, forks and spoons of precious metals;
- razors and razors, shears and hair clippers (hand instruments) and electric nail clippers.

This class does not include in particular:

- certain special instruments (consult the alphabetical list of products);
- tools and instruments driven by motor (cl.7);
- cutting instruments for surgical use (cl 10);
- the paper clips (clip 16);
- fencing weapons (cl 28).

CLASS 9 Scientific, nautical, surveying, photographic, cinematographic, optical, weighing, measuring, signaling, control (inspection), rescue and teaching apparatus and instruments; apparatus and instruments for the conduction, distribution, transformation, accumulation, regulation or control of electricity; apparatus for recording, transmitting or reproducing sound or images; magnetic record carriers, acoustic discs; CDs, DVDs and other digital recording media; mechanisms for prepaid devices; cash registers, calculating machines, data processing equipment, computers; software; fire extinguishers.

This class includes in particular:

- scientific research apparatus and instruments for laboratories;
- control apparatus and instruments for ships, such as order measuring and transmission apparatus;
- the angle transporters;
- perforated card machines for offices;
- computer programs and software of all kinds, regardless of their recording media or broadcast medium, including software recorded on magnetic media or downloaded from a remote computer network.

This class does not include in particular:

- the following electrical appliances and instruments:
- a) electromechanical equipment for culinary use (crushers and food mixers, fruit squeezers, electric coffee grinders, etc.) and other electric motor driven apparatus and instruments, all classified in class 7;
- b) the pumping or fuel supply equipment (item 7);
- c) razors and razors, shears and hair clippers (hand instruments), electric nail clippers and clothes irons (Cl.8);
- d) electric heaters, electric appliances for heating liquids, for cooking, ventilation, etc. (cl 11);
- e) toothbrushes and electric combs (cl 21);
- watch articles and other chronometric instruments (cl 14);
- the control clocks (cl.14);
- recreational devices and gaming devices that are used with external display screens or monitors (cl 28).

This class includes in particular:

- utensils and containers for domestic and culinary use, for example: kitchenware, buckets, tin cans, aluminum, plastic or other materials and small appliances for grinding, grinding, squeezing, etc., manually operated;
- electric combs;
- electric toothbrushes;
- placemats, post-bottles and coasters (crockery).

This class does not include in particular:

- certain glass, porcelain and earthenware items classified according to their function or destination (consult the alphabetical list of products);
- cleaning products, soaps, etc. (cl 3);
- small appliances for cutting, grinding, squeezing, etc., electrically operated (item 7);
- razors and razors, shears and hair clippers, metal manicure and pedicure instruments (Cl 8);
- the electric cooking utensils (cl 11);
