- The technical representative will be responsible for the execution and coordination of the project, the fulfillment of its objectives and goals, the integration of deliverables and the preparation of technical progress and final reports, reflecting the achievements made.
- The legal responsible is the natural person with the legal power to make commitments on behalf of the host institution (subject of support) and sign the necessary agreements with CONACYT-ANUIES
- The administrative manager will be responsible for the correct application, institutional distribution and execution of resources, as well as the preparation of the required financial reports. You must also be responsible for contracting the office that will audit or validate the final financial report.

#### **Basic Aspects:**

- State of the Art of the topic of the Network at the national and international level, where the frontiers of knowledge, needs, strengths, weaknesses, opportunities and medium-term projection are identified and, where appropriate, a proposal for a National Research Program in this thematic area. Include a vision of the impact that the Network can have on the development of the topic in STI and in society.
- Catalog of researchers or specialists (even if they are not members of the Network) and infrastructure related to the topic of the Network.
- Management actions to facilitate the development of science and the transfer of knowledge, including databases, proposals to simplify administrative and legal processes, update standards, or any other aspect related to the subject of the Network.
- Strategies, activities and products for dissemination and communication of knowledge, including a web page that contains: Basic information (Name of the representative of the Network and of the members.

- Mobility program for researchers and students. With whom to sign and under what agreements?
- -Program of scientific publications based on the work of the Network. All must give credit to the CONACYT-ANUIES Thematic Networks Program.
- -Strategy for the training of high quality human resources in the short and medium term, including the updating and generation of educational programs and their registration in the PNPC with the modalities of "Graduate Inter-institutional", "Postgraduate in Industry".
- -Training and academic update through courses and workshops.
- -Possibility to organize academic meetings such as congresses, symposia, etc.
- -Catalog of research projects.

- -Reading and, if applicable, approval of the minutes of the previous meeting
- -Follow-up of agreements
- -Debugging the issues to be discussed at the meeting
- -Election of the place of the next meeting
- -General business

#### **Aspects of Bonding:**

- Catalog of companies, institutions and organizations related to the topic of the Network.
- -Evidence of the linkage or alliances with sectors external to the academic (stays, agreements, meetings, workshops, congresses, etc.).
- Maps or road maps of the development of CTI in the subject of the Network (from generation to the application of knowledge and, where appropriate, generation and commercialization of patents).
- -Strategy for the registration of intellectual property generated by members of the network and, where appropriate, the distribution of profits for its commercialization.
- -Procedures or, as the case may be, advisory or consulting services on the subject of the Network for the attention of emergency problems in the country.
- -Technical training and continuing education services on the subject of the Network.
- -Possible to organize events with different sectors of society such as meetings, fairs, etc.
- -Catalog of strategic projects of technological development and innovation.
