1. Editing the article must have the following characteristics:

-May be written in Spanish or English. However, it is mandatory to submit the title and abstract in both languages, as well as keywords and JEL Classification.

-Papers must comply with the format standard.

1. The papers are reviewed by members of the Editorial Board and two anonymous. The ruling is final in all cases. After notification of the acceptance or rejection of a job, final acceptance will be conditional upon the changes in style, form and content that the publisher has informed the authors. The authors are responsible for the content of work and the proper use of the references cited therein. ECORFAN reserves the right to make editorial changes required to adapt the text to our editorial policy.

2. The identification of authorship should appear only in a first page removable, in order to ensure that the selection process is anonymous. Also requests that the author (s) (s) declare (n), in a separate letter that your article is unpublished and it is not concurrently submitted for publication elsewhere. Authors should complement the following formats: i) Authorization Format and ii) Original Format.

3. Tables, charts and other supporting materials must meet the following:

-Should be self-explanatory (without resorting to the text for your understanding), not including abbreviations, clearly indicating the title above and reference source below with reference to center alignment.

-The graphics and other supporting materials will be grayscale.

-Tables should be simple and present relevant information.

5. References are included at the end of the document, all components will be separated by a comma and must order:

a) Books: surname of author (s) (s), initial of the name, title, place of publication, publishing agency, date, number of pages: Example, Loria, Eduardo, *Econometrics with Applications*, Mexico, Pearson Prentice-Hall , 2007. Pp. 331.

b) Journals: surname of author (s) (s), initial of the name, title, article, journal name, volume number, year, pages: Example; Anchuelo, Alvaro (1993), "integrated and cointegrated series: An Introduction" , *Journal of Applied Economics*, No. 1 (vol. I). pp. 151-164

c) Other references: Example, Flores Crespo, P. (2004). Can education about development? [Book Review: *Education and economic development in Latin America and the Caribbean*]. *Electronic Journal of Educational Research*, 6 (2). Retrieved month day, year from: <http://redie.uabc.mx/vol6no2/contenido-flores.html>

The reference list must correspond with the citations in the document.

6. The notes to footnotes, which should be used and only to provide essential information is included at the end of the document. The quotations and references in the text must comply with the following order: i) References: (last date), ii) Quotations: (Last date: page [s]).

7. ECORFAN only accept the correction of typos and errors or omissions from the process of editing the E-Book Not be accepted deletions, substitutions or additions that alter the formation of the article. The author will have a maximum of 3 calendar days for the review. Otherwise, it is considered that the author (s) (s) is (are) in accordance with the changes made.
