## 3) General Objective

Generate production of Rights Reserves endorsed by the Secretary of Public Education in its following modalities:

### Previous Opinion

It will allow you to verify the background of current Rights Reserves, which could be an impediment to obtaining an equal or similar. The previous opinion is highly recommended, because if your request for Reservation of Rights is denied, the payment used for the procedure in question, is exercised without possibility of reimbursement..

### What is a reservation of rights for exclusive use?

It is the faculty that has a physical or moral person to use and exploit exclusively titles, names, denominations, distinctive physical and psychological characteristics, or original operating characteristics applied, according to their nature.

### What is the renewal of reservation of rights for exclusive use?

It is the right granted to the holder of a Reserve of Rights so that, in compliance with the provisions of the Law, it may renew for equal successive periods, the exclusive use of a title, artistic name or denomination. It is exempted from this assumption to the Advertising Promotions, which at the end of its validity will become part of the public domain.

### Marginal annotation

It is the mechanism provided by the Law, by means of which the holders of a Reserve of Rights for Specific Use determined notify the INDAUTOR:

Change of address, to hear and receive documents and notifications.

Change of Owner (name or business name) of a Reservation of Rights for Exclusive use.

The transmission of rights that cover the corresponding certificates.

### Copy Checking

In case you require the return of original documents that you have entered in the INDAUTOR through a procedure, you must attach a simple copy of the document in question, accompanied by the payment of rights by comparison. If the request for the return of the original documents is made once the process is completed, you must submit a free document, attaching a simple copy of the document in question and the corresponding payment of fees. Likewise, a copy of the official identification of the applicant or applicants must be submitted, which must contain sufficient clarity and clarity to be fully identified. (IFE Credential, National Military Service Card, Naturalization Letter, Immigration Form, Professional Certificate, Passport, INAPAM before INSEN).
